## **INVITATION TO BID FOR Procurement of Medical Equipment, Devices and Ophthalmology Supplies IB NO: 2019-022**

The *Western Visayas Medical Center*, through Hospital Generated Income, in the amount of **Three Million Two Hundred Seventy Nine Thousand Three Hundred Eighty Pesos Only (Php3,279,380.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for the ***Procurement of Medical Equipment, Devices and Ophthalmology Supplies***. Bids received in excess of the ABC shall be automatically rejected at bid opening.

1. The *Western Visayas Medical Center* now invites bids for ***Procurement of Medical Equipment, Devices and Ophthalmology Supplies***. Bidders should have completed, within **Five (5) Years** from the date of submission and receipt of bids, ***a single contract of similar nature amounting to at least fifty (50%) percent of the ABC of the item/s being bid OR the bidder should have at least two (2) similar contracts and the aggregate contract amounts should be equivalent to at least the percentage of the ABC of the item/s being bid and the largest of these similar contracts must be equivalent to at least half of the percentage of the ABC of the item/s being bid.*** The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
2. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.
3. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.
4. Interested bidders may obtain further information from the *Bids and Awards Committee (BAC) of the Western Visayas Medical Center* and inspect the Bidding Documents at the address given below during *from Mondays through Fridays 8:00am to 5:00pm*.
5. A complete set of Bidding Documents may be acquired *upon payment of a non-refundable fee in the amount of Five Thousand Pesos (P5,000.00).*

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address as stated. ***Only two (2) authorized representatives per company shall be allowed to attend the Pre-Bid and Opening of Bids. Late bids shall not be accepted.***

9. The *Western Visayas Medical Center* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
