WHEREAS the Entity invited Bids thru IB No. 2017-009 for Procurement of Various Laboratory Goods, and has accepted a Bid by the Supplier for the supply of those goods in the sum of ONE MILLION SIXTY FIVE THOUSAND PESOS ONLY (Php1,065,000.00) hereinafter called the "CONTRACT PRICE".

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the items below and to remedy defects therein in conformity in all respects with the provisions of the Contract.

6. The validity of this Contract is only for one (1) year from the signing of this Contract.




