Contract Agreement

THIS AGREEMENT made the ____ day of DEC 18 2007 between:

WESTERN VISAYAS MEDICAL CENTER of the Philippines with office address at O. Abeto St., Mandurriao, Iloilo City represented by Medical Center Chief II, JOSEPH DEAN L. NICOLO, M.D. herein referred to as the "ENTITY" of the one part

-and-

MRL CYBERTEC CORPORATION, represented herein by its authorized Representative, CRISTHINE MAE F. GARBOSA with business address at, 3rd Floor MRL Tower No. 124, Malakas Street, Central District Diliman, Quezon City, Metro Manila, hereunder referred to as the "SUPPLIER" of the other part.

WHEREAS the Entity invited Bids thru IB No. 2017-009 for Procurement of Various Laboratory Goods, and has accepted a Bid by the Supplier for the supply of those goods in the sum of SEVEN HUNDRED THIRTY SIX THOUSAND PESOS ONLY (Php736,000.00) hereinafter called the "CONTRACT PRICE".

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
