**SUBJECT: AMENDMENT TO DEPARTMENT ORDER NO. 2008-0136
DATED 30 MAY 2008 REGARDING REVISED GUIDELINES ON
RECRUITMENT AND SELECTION OF APPOINTEES IN ALL
LEVELS OF POSITIONS IN THE DEPARTMENT OF HEALTH**

Department Order No. 2008-0136 dated 30 May 2008 regarding *Revised Guidelines on Recruitment and Selection of Appointees in all Levels of Positions in the Department of Health* is hereby amended as follows:

IV. IMPLEMENTING GUIDELINES

4.13 All Chief of Hospital/Sanitarium positions shall be appointed by the Secretary of Health.

4.14. Chief Medical Professional Staff positions in hospitals shall be evaluated by a Special Promotion and Selection Board. The following special PSB shall be created:

4.14.1. One hospital PSB for all Metro Manila Hospitals

4.14.2. A CHD PSB per region for Hospitals under the Centers for Health Development.

4.15 Appointments of CMPS shall be approved by the Secretary of Health currently delegated to the appropriate Undersecretary concerned.


