Contract Agreement

THIS AGREEMENT made the ____ day of 12 FEB 2020 20 ____ between:

WESTERN VISAYAS MEDICAL CENTER of the Philippines with office address at O. Abeto St., Mandurriao, Iloilo City represented by Medical Center Chief II, JOSEPH DEAN L. NICOLO, M.D. herein referred to as the "ENTITY" of the one part

-and-

RCL OPHTHALMIC SURGICALS, represented herein by its Authorized Representative, JACLYN B. ARBIAS, with office address at Room 02-9, 2/F JEV Arcade Bldg., Colon St., Pahina Central, Cebu City, hereunder referred to as the "SUPPLIER" of the other part.

WHEREAS the Entity invited Bids thru IB No. 2020-003 for the Procurement of Various Ophthalmology Supplies, Devices and Instruments, and has accepted a Bid by the Supplier for the supply of those goods in the sum of One Million Three Hundred Nine Thousand Pesos Only (Php 1,309,000.00) hereinafter called the "CONTRACT PRICE".

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:
 - (a) the Supplier's Bid, including the Technical and Financial Proposals, and all other documents/statements submitted;
 - (b) the Schedule of Requirements;
 - (c) the Technical Specifications;
 - (d) the General Conditions of Contract;
 - (e) the Special Conditions of Contract;
 - (f) the Performance Security; and
 - (g) the Entity's Notice of Award.
3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the items below and to remedy defects therein in conformity in all respects with the provisions of the Contract.

4. Performance Security. To guaranty this contract Supplier submits its Performance Security through a *Surety Bond* from *Milestone Guaranty and Assurance Corp.*, in the sufficient amount of Three Hundred Ninety Two Thousand Seven Hundred Pesos Only (Php 392,700.00).

5. The Entity hereby covenants to pay the Supplier from the release of Inspection and Acceptance Report in consideration of the provision in accordance with the GCC Clause 10 of the Bidding Documents and the remedying defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.

6. GCC Clause 6.2 on the Scope of the Contract states that:

- *Contract for the Procurement of Various Ophthalmology Supplies, Devices and Instruments is one (1) year subject to the semi-annual evaluation of the End-user and Property and Supply Office based on the following criteria; (a) The Quality of goods and (b) Efficiency in the delivery of goods.*
- *Additional request for purchase of the ophthalmology supplies may be reordered or negotiated if quality and prices are maintained as the bid price within the one year contract period.*
- *Expiry for the ophthalmology supplies shall be at least eighteen (18) months or more from the date of delivery.*

7. GCC Clause 17.3 of the Special Conditions of the Contract states that:

- *The Procuring Entity shall not accept items that had been tampered with, or altered in any way or which has the serial number or its equivalent altered, effaced or removed.*

8. GCC Clause 18.1 of the Special Conditions of the Contract states that:

- *Delivery of Goods / Consumables shall be based on the schedule of delivery of all items due to lack of storage to stock its supplies, WVMC reserves the right to accept only the delivery required as to capacity of its storage. Staggered delivery shall be resorted to in accordance to the capacity of the storekeeping within WVMC.*
