The *WESTERN VISAYAS MEDICAL CENTER*, through the *Regular Agency Fund GAA/SAA or Internally Generated Fund-Hospital Income* intends to apply the sum of **Two Million Nine Hundred Seventeen Thousand Pesos Only (Php2,917,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for the ***Procurement of Labor and Materials for Repair of Various Civil Works (Re-bid)***. Bids received in excess of the ABC shall be automatically rejected at bid opening.

1. The *WESTERN VISAYAS MEDICAL CENTER* now invites bids for the procurement of for the following projects:

2. Completion of the Works to comply with Detailed Unit Price Analysis as required. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and

Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act.”

4. Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
5. Interested bidders may obtain further information from *Bids and Awards Committee (BAC) of the Western Visayas Medical Center* from *Mondays through Fridays 8:00am to 5:00pm*.
6. A complete set of Bidding Documents may be acquired *upon payment of a non-refundable fee in the amount of **Five Thousand Pesos (5,000.00)**, if the bidder bids for all the lot items.*

If the bidder opts to bid for one or more lots, the aggregate ABC for the said/specified lots shall be the basis for the cost of Bidding Documents as prescribed in Appendix 8 Guidelines on the Sale of Bidding Documents.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

Late bids shall not be accepted.***

The *WESTERN VISAYAS MEDICAL CENTER* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
