**INVITATION TO BID FOR
WAREHOUSE RENTAL FOR ONE YEAR
IB No. GS 2020-006**

1. The *Western Visayas Medical Center*, through the *Regular Fund and Collection of Income*, intends to apply the sum of **PhP 2,640,000.00** Philippine Currency being the Approved Budget for the Contract (ABC) to payments under the contract for *IB No. GS 2020-006 Warehouse Rental for One Year*. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *Western Visayas Medical Center* now invites bids for *Calibration of Various Health Care Equipment*. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".
 - (i) Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.
 - (ii) Only bids from bidders who pass the eligibility check will be opened. The process for the eligibility check is described in Section II of the Bidding Documents, ITB. The bidder with the lowest calculated bid (LCB) shall advance to the post-qualification stage in order to finally determine his responsiveness to the technical and financial requirement of the project.
 - (iii) The contract shall then be awarded to the **Lowest Calculated and Responsive Bidder (LCRB)** who has determined such during the post-qualification procedure.
4. Interested bidders may obtain further information from *Western Visayas Medical Center Bids and Awards Committee for Drugs and Medicines/General Services* and inspect the Bidding Documents at the address given below from September 21, 2020 to October 12, 2020 during 8:00 AM – 5:00 PM.
5. A complete set of Bidding Documents may be acquired by interested Bidders on *September 21, 2020 to October 12, 2020 on or before 9:00 AM* from the address below

and upon payment of a non-refundable fee in the amount of **PhP 5,000.00**, the method of payment will be in cash. The Bidding Documents shall be received personally by the prospective bidder or by his Authorized Representative.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The *Western Visayas Medical Center* will hold a Pre-Bid Conference at **9:00 AM on September 30, 2020** at **MCC Office Lobby Area, WVMC, Mandurriao, Iloilo City**, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or before **9:00 AM on October 12, 2020**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on **October 12, 2020 at 9:15 AM** at **MCC Office Lobby Area, WVMC, Mandurriao, Iloilo City**. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

8. Partial bid is not accepted.
9. The *Western Visayas Medical Center* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
