The *Western Visayas Medical Center*, through the 2021 GAA, RA 11518 or *Hospital Income* intends to apply the sum of **Seventeen Million Twenty Eight Thousand Thirty Two Pesos and 43/100 Only (Php17,028,032.43)** being the Approved Budget for the Contract (ABC) to payments under the contract for ***Procurement of Infrastructure Projects of WVMC for CY 2021 (Re-bid), IB No. 2021-041-I***. Bids received in excess of the ABC shall be automatically rejected at bid opening.

6. A complete set of Bidding Documents may be acquired by interested Bidders upon payment of a non-refundable applicable fee, in the amount of **Twenty Five Thousand Pesos (Php25,000.00)**. If the bidder opts to bid for one or more lots, the aggregate ABC for the said/specified lot/s shall be the basis for the cost of Bidding Documents pursuant to the latest Guidelines issued by the GPPB, Guidelines on the Sale of Bidding Documents. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person.
