INVITATION TO BID FOR ONE (1) LOT TRANSPORT, TREATMENT, AND DISPOSAL OF ASSORTED HAZARDOUS AND INFECTIOUS WASTES IB No. GS 2021-003

1. *Western Visayas Medical Center* through the **CY2021 Regular Agency Fund-GAA/Internally Generated Fund-Hospital Income** intends to apply the sum of **Seventeen Million Pesos Only (PHP 17,000,000.00)** being the ABC to payments under the contract for **IB No. GS 2021-003 Invitation to Bid for One (1) lot Transport, Treatment, and Disposal of Assorted Hazardous and Infectious Wastes**. Bids received in excess of the ABC shall be automatically rejected at the bid opening.
2. The *Western Visayas Medical Center* now invites bids for the above Procurement Project. Delivery of the Goods is required to commence within *thirty (30) calendar days from receipt of Notice to Proceed*. Bidders should have completed, within **one (1) year** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "*pass/fail*" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
 - a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
4. Prospective Bidders may obtain further information from *Bids and Awards Committee (BAC) of the Western Visayas Medical Center* and inspect the Bidding Documents at the address given below during *from Mondays through Fridays 8:30am to 4:30pm*.

A complete set of Bidding Documents may be acquired by interested Bidders upon payment of a non-refundable applicable fee for the Bidding Documents, in the amount of **Twenty-Five Thousand Pesos (Php25,000.00)** in accordance with Appendix 18 of the 2016 Revised Implementing Rules and Regulations of R.A. 9184.

The Procuring Entity shall allow the bidder to present its proof of payment personally for the fees.


6. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated above. Late bids shall not be accepted.
